### **Executive Director's Report**

July 15, 2025

Dear Members of the Board and Public,

Happy Summer and I hope everyone is finding ways to stay cool! There is a lot going on around the agency and I'm thrilled to be sharing these updates.

#### **2025** Legislative Session

The 89<sup>th</sup> Texas legislative session ended on June 2<sup>nd</sup> and it was a great one for TBVME! In the budget, the agency was awarded \$500,000 for the completion and final buildout of our database system to include enforcement, legal and compliance. This will turn our licensing system into a full case management system, which will streamline processes and help ensure more accurate data is collected. The most exciting part is that we were given the money outright as part of a larger technology modernization budget item rather than having to fund this project through licensing fees. SB2155 passed in the waning hours of the session, this bill is the product of legislative recommendations made by TDLR with our input, pursuant to SB 1414 from last session. Some big changes from this bill include facility registration, streamlining the process for prosecution of practice without license cases and the ability to issue emergency orders to close facilities. Finally, with the passage of HB1545, the agency's next Sunset date has been moved from 2027 to 2033.

#### **Full Rule Review**

Pursuant to SB1414 (the Sunset bill) from last session, as part of the attachment to TDLR, TBVME is required to fully review and update our rules. It is a big undertaking but to make this as easy as possible, we will be proposing a new version of each chapter of our rules at each Board meeting starting in October. Staff, in conjunction with TDLR, will draft an initial version of the updated chapter and present it to the Rules Committee. The Rules Committee will provide their review and input and that draft will be presented to the full Board for consideration. Chapter 571- Licensing will be first up. This is going to be a heavy lift for the Board for the next year, but it's one of the final steps needed to truly modernize the agency.

#### **New Inspection System**

Our fantastic systems administrator, Femi Salami, has been hard at work in conjunction with the Enforcement team on building out an inspection system in our database. This will help cut down on the use of spreadsheets for data tracking and streamline the pre-inspection process currently in place. We will be giving all our field investigators tablets with the application loaded onto it, also cutting down on extraneous paperwork. Testing of the system will begin this month and we anticipate formally launching this new system at the start of the new fiscal year in September.

#### **Staffing Updates**

Mary Monk, our legal secretary, will be leaving the agency at the end of this month to

attend law school. She will be missed but we are so excited for her to embark on this new journey. Our new legal secretary, Angela Murillo, joined the agency earlier this month and is here with us today. Angela comes to us from the Attorney General's Office, and we are so excited to have her.

Michael Gromatzky and Yesenia Sabelhaus, two of our investigators, both left the agency in June to pursue other opportunities. We wish them all the best! K 'Shel Bell, current Houston investigator, will be relocating to fill the Austin/Central Texas regional role. We have hired Mark Schilli and Rachel Treiber to fill out our two Houston area investigator roles. Mark is a retired DEA agent and supervisor who brings over 30 years of law enforcement experience to the agency. Rachel is a former veterinary practice manager who brings a wealth of industry experience to the agency. We are thrilled to welcome all three of our new team members!

#### **Board Notes**

We will be launching Board Notes, our quarterly newsletter to licensees and anyone signed up for updates after this Board meeting. I welcome input and suggestions for different or additional information to include. Thank you to Dr. Golla, Dr. McLeod and Dr. Moczygemba for writing articles that have (or will!) appeared in the TVMA magazine and will also be featured in our newsletters.

#### **Extern Program**

The agency will welcome its first extern later this summer. Our extern, Alex Isler, is a joint DVM-MPH candidate at Texas A&M and is particularly interested in regulatory policy and the intersection of veterinary medicine and government. Alex will be assisting the legal department with research related to our rule making efforts. We hope to expand and continue this program going forward.

#### **Case Resolution Time**

One of our most challenging performance measures to meet has been our average case resolution time. My first year on the job, our average was over 560 days for case resolution. This last quarter, we reported an average of 394 days. While this is still far from our goal, this is incredible progress that I wanted to highlight. This improvement is the result of collaboration and effort from our enforcement, legal and medical review teams. Please keep up the hard work!





#### **Compliance Report**

July 15, 2025

The Compliance Department currently has 37 licenses that are being monitored regarding Board Orders. The task of DPS Fingerprint validations is continuing to be done daily and will continue for years to come. Every licensee will have their fingerprints validated after 5 years to make sure they are still an active licensee per state and federal guidelines. Staying on the fingerprint topic, 940 total new fingerprints have been reviewed for applicants in the 2025 FY.

The Compliance Department (Director Honrath) has fielded 409 phone calls for compliance, licensing, fingerprints, CE, and general agency related questions from licensees and applicants so far in FY 2025. The number of calls is declining as more information is now on our website and employees are getting well versed in our agency's rules and regulations. The Compliance Department has also assisted with 131 inter-agency related requests from the various departments in FY 2025.

Finally, CEs are required to be uploaded upon license renewal and if not, an extension may be granted with auditing taking place when extension due dates are expired. This is being tracked through our new database, and compliance so far with these CEs extensions has been impressive. 18 cases for CE non-compliance have been transferred to Enforcement for further investigation as of this time. And lasty, 4 complaints have been referred to Enforcement over the past month for Violations of Board Orders.
